Base Bid:

The Base Bid portion of the project will consist of placing 1.5" of asphalt concrete over the existing high school east parking lot and feeder roads as outlined in the plans.

Alternate Bid No. 1:

Alternate No. 1 will consist of scarifying the existing high school east parking lot by pavement planing, to a depth of 1/4" to 1/2". The planing area will match the Base Bid area of the high school east parking lot as outlined in the plans.

Alternate Bid No. 2:

Alternate No. 2 will consist of placing 1.5" of asphalt concrete over the existing high school west parking lot and feeder roads as outlined in the plans.

Alternate Bid No. 3:

Alternate No. 3 will consist of scarifying the existing area adjacent to the track by pavement planing, to a depth of 1/4" to 1/2", and asphalt concrete resurfacing of 1.5" as outlined in the plans.

Alternate Bid No. 4

Alternate No. 4 will consist of placing 4" base pipe underdrains as well as an 8" header pipe within the limits of the existing high school east parking lot as outlined in the plans.
